

ORDER OF SPECIAL CONSTITUTIONAL AMENDMENT ELECTION FOR LEON COUNTY

An election is hereby ordered to be held on May 7, 2022, in Leon County, Texas, for voting in a special election to adopt or reject the proposed Constitutional Amendments as submitted by the 87th Legislature Special Session, of the State of Texas.
