REQUIRED FLOODPLAIN DETERMINATION AND PERMITTING INFORMATION

On Wednesday, **November 20, 2013**, new flood maps for Leon County, Texas became effective.

Because Leon County participates in the National Flood Insurance Program, **all new construction, manufactured home placement and substantial improvements including but not limited to water supply systems and sanitary sewage systems, require a floodplain determination/development permit.** The landowner should contact the County Judge's office or their local City office to receive information on floodplain determination/permitting procedures, and to obtain an application. This is intended to inform the landowner of their responsibilities.

The proposed development/construction **may not begin until after written authorization has been issued from the County Judge or City office.**
