

Notice About 2026 Tax Rates

Property tax rates in County of Leon.

This notice concerns the 2026 property tax rates for County of Leon. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year's no-new-revenue tax rate	\$0.406160/\$100
This year's voter-approval tax rate	\$0.434507/\$100

Voter-Approval Tax Rate Adjustments

State Criminal Justice Mandate

The County of Leon Auditor certifies that County of Leon has spent \$170,244 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. County of Leon Sheriff has provided County of Leon information on these costs, minus the state revenues received for reimbursement of such costs. This increased the voter-approval tax rate by 0.004088/\$100.

This notice contains a summary of actual no-new-revenue and voter-approval calculations as certified by Victoria Willis, Leon County Tax Assessor Collector on 08/04/2026 .

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
