On the 28th day July, 2025, the Commissioners' Court of Leon County met in regular session.

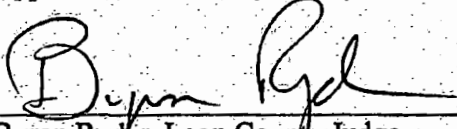
Upon motion by Joey Salove, and seconded by
